Dear Members of the CIMS!

In view of the general economic situation, the Board of Directors has decided to *raise the membership dues* to the levels indicated in the adjoining table *). Income from membership dues makes up only a modest part of the very large costs of activities like the Symposia we conduct, the studies and publications we sponsor, and the International «House of Church Music» we support, among other things. Indeed, the bulletin of information «Musicae Sacrae Ministerium» cannot actually be financed by membership dues alone, and thus the dues should rather be regarded as a sign of membership, and as a modest but necessary sacrifice for the sake of symbolically supporting the good cause we have in common.

Those members who have not paid any dues for several years are kindly requested to please inform us if they no longer wish to remain in the CIMS, so that all of us will know exactly where we stand.

As to the *method of payment*, we urgently recommend the much cheaper *postal remittance* (e.g. international money order), since the costs and fees deducted from a normal bank check (which must be converted into Belgian currency) amount to almost twenty-five percent! Therefore: please pay any dues you may still owe for 1976 or 1977, and in any case those for 1978, to the *postal savings account Luxembourg No. 2088-51*, «Banque de Suez - La Luxembourgeoise» with the notation: For CIMS, 400.1.7561-01. Your cooperation will be greatly appreciated. Thank you!
